Purchasing energy rated frames with glazing from Climatec and Alu-tec just requires a tick box on our order forms.

### BECOME AN AUTHORISED RETAILER:

You can apply to become Authorised retailers via the **BFRC\*** – see contact form here - [www.bfrc.org/contact-us](http://www.bfrc.org/contact-us)

**Application form** – The BFRC will send you an application form to complete. As you are a New Applicant Installer wanting a sub licence, you just need to complete Sections 1, 2, 4 and 5. **Ignore Section 3**.

Section 4 asks you to specify what licences you want. You can tick the box for **'all licences'** (this is the easier option), or you can choose the licences you do require from the list of energy rated windows as mentioned above.

Once you have applied the BFRC will then send you an email advising your application has been approved, your details will be listed on their website and you will have rainbow coloured label artwork to use too.

When this has been done, please advise Climatec so this can be recorded and the Order Processing team can be advised that you are buying energy rated products unglazed from us.

**\*If using other compliance providers, please refer to their procedures for energy rating compliance and send details to Climatec for Order Processing.**

**REMEMBER, IT WILL BE UP TO YOU TO INSTALL THE CORRECT GLASS SPECIFICATION FOR YOUR REQUIRED COMBINATION OF WINDOW BUILD AND DESIRED ENERGY RATING.**

**If you cannot find your required specification on our certified products list, it means you will not be able to supply an energy rated product for your customer and would need to provide a U value compliant product instead.**
